THE BASIC RULES OF PARTICIPATION IN “SPORTY DAY CAMP”

1. Organizer of “Sporty Day Camp” is MK Sport Monika Kiepal located on Wiśniowa 11, 05-500 Stara Iwiczna, Nip 1231246687
2. Kids from age 6 to 13 are allowed to participate in the Day Camp. In some individually decided instances, kids of different ages are allowed to take part in Camp activities.
3. Conditions of participation in the Camp are:
 - a) reservation made:
 - by phone (+48 575 013 311) or by email (recepca@garden-club.pl)
 - personally in the club’s reception
 - b) fulfilling and resending form of participation (<https://bit.ly/3y6hMca>)
 - c) payment for the whole 5-days long camp (that is: 990 PLN for every kid) not later than 14 days prior to beginning of the chosen Camp term
Payment for participation should be made:
 - by card or cash in the Garden Club’s reception or
 - by bank transfer to account number 39 1440 1101 0000 0000 1367 8267 MK Sport MONIKA KIEPAL UL. Wiśniowa 11 05-500 Stara Iwiczna - Transfer title “Sporty Day Camp, Name and Surname of the child”
4. Conclusion of the contract with MK Sport Monika Kiepal is taking place in the moment of signing of the form of participation available under the address <https://bit.ly/3y6hMca>
5. Resignation from the camp is possible only in the form of a written statement given directly to the reception of Garden Club not later than 7 days prior to the beginning of the chosen camp termin. Approved is also the electronic version of said statement sent to recepca@garden-club.pl. The date of acceptance of the said statement is deciding about the resignation costs of the parent/legal guardian. The vacant spot on the list made by the resignation stays under the organizer’s full control.
6. The only case when eventual refund of the costs takes place is resignation caused by a random event proven by a written medical report delivered not later than 7 days prior to the start of the chosen day camp termin. In this case Club refunds 50% of the full day camp cost in the next 14 working days or suggests possible other dates of participation.
7. If any refunds are made, the legal guardian/parent has no entitlements for interests from made payments.
8. Organizer has the right to change the conditions of the contract (e.g. date of the event etc.) if caused by causes independent from him. In this case, the organizer is committed to inform the legal guardian/parent about the made change. The legal guardian/parent is committed to inform the organizer about their acceptance of the new conditions or resigning from the event in 3 days after being informed about said change of condition. In the case of registration, the organizer is committed

to refund all of the costs the legal guardian/parent took to that moment. The lack of answer in the 3 day period is understood as an agreement to the new conditions.

9. Organizer has the right to cancel the event, in which case he will inform the legal guardian/parent as soon as possible. In case of canceling, the organizer refunds full payment.

10. The legal guardian/parent has no rights to the refund of the benefits not used in the period during the day camp caused by the participant.

11. Every participant of the event is insured by the organizer from the results of the unlucky accidents during the camp. Eventual loss has to be brought to the organizer's attention not later than 7 days after the end of the event to gather information about further actions.

12. Organizer can not be blamed for the results of actions made by force majeure, which the organizer could not counteract and losses of objects left on the terrain of the club.

13. Participants of the camp are taken care of by Garden Club's trainers from the moment of delivering the participant to Club's reception by legal guardian, but not earlier than 8:45 AM, and stays under said care until regaining by legal guardian documented by trainer or Club worker, but not later than 5 PM. Care after 5PM is possible only under the terms of additionally payable personal training priced by the club's price list.

14. Organizer is responsible of taking care of the participant from the moment of leaving the children in the club by the legal guardian/parent in the days and hours of the camp

15. Unfulfillment of the camp plan can occur only when the organizer is met with objective, random events - such as unfavorable weather conditions - which the organizer can not be blamed for. Every complaint about the services and their quality should be made as soon as possible, but not later than 7 days after the ending of the event.

16. Legal guardian/parent is obliged to recompensating any possible material losses made by the participant purposely.

17. Any situations not taken under consideration in this document will be looked upon by MK Sport Monika Kiepal or authorized worker during 14 working days after filing a complaint by the legal guardian/parent.

18. The legal guardian/parent is consenting to fixation and distributing the image of their child free of charge on film or video by organizer, in pursuance of art. 81 ust. 1 ustawy o prawie autorskim i prawach pokrewnych z dnia 4 lutego 1994r. – Dz. U. 2006 r. nr 90 poz. 631 z późn. Zm. Distributing the image of a child is possible by any medium without any time limits.

19. Administrator of the personal data is MK Sport Monika Kiepal, Wiśniowa 11, 05-500 Stara Iwiczna

20. Participants of the camp are obliged to abide by the rules of the Sporty Day Camp.

21. Participants of the camp are obliged to abide by the rules of the Garden Club Sports&Health, accessible in the club's reception.
